2012 Gunnison Farmer's Market**

Non-profit organizations are welcome to submit an application to have a booth at the 2012 Farmer's Market. The Board of Directors will review all applications and invite those organizations that directly support the letter and spirit of the Market's goals to participate. All decisions are at the discretion of the Board and are subject to space availability. Note that any organization promoting political or religious views, individuals or causes will not be allowed at the market.

The regular outdoor market will open Saturday, June 23 and close Saturday, October 6. The indoor season will run through Saturday November 3. Hours will be 9:30 a.m. - 1:30 p.m.

The goals of the Gunnison Farmer's Market are to:

- Promote appreciation for Colorado's rural resources
- Provide area farmers and value-added food producers a market where they can sell directly to the consumer
- Provide customers a market where they can talk directly to the producer
- Get the freshest products possible, provide local craftsmen with an outlet for the sale of their handmade products (local means produced in Colorado, with the exception of products not available in Colorado, at the discretion of the Board)
- Encourage and assist people, young and old, to learn about environmentally sound agricultural and business practices
- Develop sources of marketing, management and agricultural information for its members and community, and to provide a venue for local entertainers.
